

ELMER'S GLUE CREW RECYCLING PROGRAM PROMOTION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

- Promotion Period.** The Elmer's Glue Crew Recycling Program promotion (the "Promotion") begins at 12:01 am Eastern Time ("ET") on September 1, 2010 and ends at 11:59 pm ET on May 20, 2011 (the "Promotion Period").
- Eligibility.** Participation open only to Elmer's Glue Crew Recycling Program Members who are certified practicing teachers employed at a public or private educational institution (K – 12) located in the 50 United States (excluding the State of Rhode Island) or the District of Columbia and 21 years of age or older as of date of entry. Teachers who are interested in becoming a member of the Elmer's Glue Crew Recycling Program should log onto www.elmersgluecrew.com and follow the directions to sign-up as a member of the program. Eligible teachers must enter on behalf of their (one) classroom and not as an individual or on behalf of multiple classrooms or a school. Entries on behalf of an individual, school or multiple classrooms will be disqualified. This Promotion is void where prohibited. Employees, officers and directors of Elmer's Products, Inc. - How to Enter. Teachers must include on their online entry form their full name, e-mail address, phone number, grade taught, name of school, address of school, district of school, principal's name, and number of students in the classroom/homeroom class. Students may not enter and no personal information from or about students will be collected. All entries must include a valid e-mail address.

In addition to the online entry form, entrants must submit original materials that represent his/her classroom's commitment to recycling and the Elmer's Glue Crew Recycling Program (the "Program"). For more information on the Program, visit www.elmersgluecrew.com. All submissions must be made electronically via submission form found in Step 4 of How It Works section of www.elmersgluecrew.com. Electronic submissions must be in text. No video content will be accepted. Materials submitted via Elmer's Contact Us webpage will not be accepted. There is no limit on the number of materials teachers can submit during the Promotion Period, nor the frequency of which materials are submitted. Submitted materials must be original, unpublished, cannot have been submitted in any other competition, and must not infringe or violate any third-party rights, including but not limited to the rights of copyright, trademark and publicity. No automated entry devices and/or programs permitted. All entries become the sole and exclusive property of Sponsor and receipt of entries will not be acknowledged or returned. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. - Winners Selection/Judging Criteria.** The winning entries will be selected based on the level of creativity and innovation demonstrated in the materials submitted. Examples of materials that demonstrate the teacher's classroom's commitment to recycling and the Program include, but are not limited to: recycling-themed lesson plans, projects, tips, and classroom glue bottle and glue

stick collection goal. The winning entries will be chosen by Sponsor on or about May 25, 2011, whose decision shall be final.

5. **Prizes.** Total approximate retail value ("ARV") of all prizes not to exceed \$4,600. No more than the number of prizes listed below will be awarded in this Promotion. Odds of winning depend on the number of eligible entries received for the Promotion. All prizes are awarded to the school at which the winning teacher is employed, in the name of the teacher and his/her classroom ("Winner(s)").

6. **Notification.** Each winning teacher and his/her school will be notified by e-mail and/or postal mail on or about __June 1, 2011_____. Each winning teacher, an administrator at his/her school and each student in the winning teacher's classroom will be required to sign and return, where legal, an Affidavit of Eligibility, Liability/Publicity Release and Publicity Release (collectively, the "Prize Claim Documents") within ten (10) days of prize notification. Each student must have the Liability/Publicity Release signed on his/her behalf by his/her parent or legal guardian. In the event the prize notification is returned as undeliverable, any winner rejects his/her prize, a prize is undeliverable, or a winner is found to be ineligible or not in compliance with these Official Rules and requirements (including student-signed Prize Claim Documents), such prize will be forfeited and an alternate winner will be selected from all remaining eligible entries. Any potential winner may be requested to provide Sponsor with proof that such winner is the authorized account holder of the email address associated with the winning entry.
